

NERIVIO REWARD PROGRAM TERMS AND CONDITIONS

Theranica Bio-Electronics Ltd. (“**Theranica**”, “**we**”, “**us**”, “**our**”) owns and operates the Nerivio app (“**App**”), and is excited to offer its App users (“**user(s)**”, “**you**”) the Nerivio Reward Program, together with the content, incentive and rewards, information sharing and other relevant services (the “**Program**”).

Please read the following terms and conditions governing the Program (the “**Terms**”). By participating in the Program, you signify your consent to these Terms. These Terms are subject to the End User License Agreement and Privacy Policy found in the App, and any capitalized terms not defined herein shall have the meaning ascribed to them in the End User License Agreement or Privacy Policy, as applicable. In the event of any conflict or inconsistency between these Terms and the End User License Agreement, the End User License Agreement shall prevail. If you do not agree to all of the terms, or if you are not eligible or authorized to enter into these Terms, then do not access or participate in the Program.

1. Eligibility.

You must be at least 18 years of age to enroll in the Program. If you do not so qualify, you are prohibited from accessing and registering for the Program. Theranica will not knowingly collect personally identifiable information from any person that is actually known to us to be a child under the age of 18. Theranica may refuse to offer or continue offering the Program to any person or entity and may change its eligibility criteria from time to time.

2. Rewards Program.

Users can accumulate and redeem Nerivio rewards points (“**Points**”), on an individual basis and solely for their own account, by providing feedback and answering questions in the App.

Users may redeem accumulated points in exchange for coupons as provided in the App (“**Coupons**”), and we will send “purchased” coupons to you via the App, and/or the email address provided by you and/or via our web interface. If you do not redeem accumulated points within any twelve (12) month period, Theranica shall expire your accrued but unused redeemable points. For the avoidance of doubt, it is your sole responsibility to monitor your points status, which is available to you in the App. We also reserve the right to send you periodic notifications through the App, encouraging you to earn and/or redeem your Points.

Users acknowledge and agree that:

- Points have no “real world” or cash value.
- Points have no purpose or use except in exchange for the Coupons offered by us through the Program.
- Redemption offers may be time-limited or available only in limited quantities.
- Your Points cannot be redeemed by, sold or otherwise transferred to, any other user of the Program.
- Points are not valid unless earned in strict compliance with the requirements as established in these Terms and intended by Theranica, and you shall not attempt to earn Points by any means (including without limitation, by using any script, bot or other automated means) that only simulates compliance with the applicable requirements.
- Our good faith determination of the amount of Points available to you or any other user shall be final and binding.

3. Participation in Promotions by Vendors.

Any dealings of users with vendors who may accept Coupons (each, a “**Vendor**”), or participation in promotions, including the delivery of and the payment for goods and services related to the Coupons, and any other terms, conditions, warranties, or representations associated with such dealings or promotions, are solely between you and the applicable Vendor. Theranica is not responsible or liable for any part of any such dealings or promotions.

4. Right to use Responses.

Theranica has all right, title and interest in any, submission, and/or responses to the questionnaires by any user (“**Responses**”). By submitting Responses, each user hereby represents and warrants that (i) the Responses do not infringe the rights, including, but not limited to, intellectual property and/or privacy rights, of any third party, and (ii) that use of the Responses by Theranica will not infringe or violate the rights of any third party.

5. Disclaimer

THE PROGRAM IS PROVIDED TO YOU "AS IS" AND "AS AVAILABLE" , AND WITHOUT WARRANTIES OF ANY KIND EITHER EXPRESS OR IMPLIED. THERANICA HEREBY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY, TITLE, FITNESS FOR A PARTICULAR PURPOSE, NONINFRINGEMENT, AND THOSE ARISING BY STATUTE OR FROM A COURSE OF DEALING OR USAGE OF TRADE.

6. Limitation of Liability

IN NO EVENT SHALL THE AGGREGATE LIABILITY OF THERANICA FOR ANY DAMAGES ARISING UNDER THESE TERMS OR OUT OF YOUR USE OF, OR INABILITY TO USE, THE PROGRAM EXCEED THE TOTAL AMOUNT OF FEES, IF ANY, PAID BY YOU TO THERANICA FOR USING THE APP DURING THE THREE (3) MONTHS PRIOR TO BRINGING THE CLAIM.

IN NO EVENT SHALL THERANICA NOR ANY OF ITS RESPECTIVE AFFILIATES, CONTRACTORS, EMPLOYEES, SHAREHOLDERS, MEMBERS, PARTNERS, LICENSORS AND SUPPLIERS BE LIABLE CONCERNING ANY SUBJECT MATTER RELATED TO THE PROGRAM, REGARDLESS OF THE FORM OF ANY CLAIM OR ACTION (WHETHER IN CONTRACT, NEGLIGENCE, STRICT LIABILITY OR OTHERWISE), FOR ANY (A) MATTER BEYOND ITS REASONABLE CONTROL, (B) LOSS OR INACCURACY OF DATA, LOSS OR INTERRUPTION OF USE, OR COST OF PROCURING SUBSTITUTE TECHNOLOGY, GOODS OR SERVICES, (C) INDIRECT, PUNITIVE, INCIDENTAL, RELIANCE, SPECIAL, EXEMPLARY OR CONSEQUENTIAL DAMAGES, LOSS OF BUSINESS, REVENUES, PROFITS OR GOODWILL, EVEN IF THERANICA HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. You agree to defend, indemnify and hold harmless us and our affiliates, and our respective officers, directors, employees and agents, from and against any and all claims, damages, obligations, losses, liabilities, costs and expenses (including but not limited to attorney's fees) arising from (i) your use of, or inability to use, the Program and/or a coupon, (ii) any transaction with any Vendor, and (iii) your violation of these Terms.

8. Privacy

You hereby acknowledge that in participating in the Program, you may provide us with personal data. You hereby authorize us to process any personal data which you decide to provide us while participating in the Program, in accordance with our End User License Agreement and Privacy Policy available in the app. You hereby warrant that you will not provide us with any personal data of a third party, and/or any information which relates to any other identified or identifiable person.

9. Changes

Theranica reserves the right, at its sole discretion, to modify or replace these Terms, or discontinue the Program, in whole or in part, at any time and at its sole discretion. Theranica will use reasonable efforts to notify you of any material change at least ten (10) days in advance of the effective date of any change. Continued participation in the Program following such notice of any change to these Terms constitutes your acceptance of those changes.

10. Termination.

Theranica may terminate your participation in all or any part of the Program at any time, with or without cause, with or without notice, effective immediately. If you wish to terminate your registration and account, you can do so by sending an email directly to Theranica customer support at support@theranica.com or info@theranica.com. Upon termination of your registration to the Program, or termination of your End User License Agreement for any reason, all Points are lost to the extent permitted by law, regardless of how they were acquired by you. Any provision included in these Terms that by its nature should survive termination of these Terms, shall do so.
